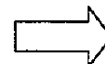


**VOLUNTEER COMPREHENSIVE WAIVER AND RELEASE FORM****CROSS CATHOLIC OUTREACH, INC.**

I am executing this Comprehensive Waiver and Release ("Waiver and Release") in consideration of being allowed to participate in a volunteer "Mission Trip" to Dominican Republic (the "Activity") organized by CROSS CATHOLIC OUTREACH, INC., a Florida non profit corporation, or its affiliate ("Cross"). I acknowledge that travel to a foreign country in general, and to Dominican Republic (one of the world's poorest countries, which has been plagued by natural disasters, political unrest, crime and infectious diseases) in particular, carries with it risk of loss or damage to property, personal injury, contracting illnesses or infectious diseases, or even death and I elect to participate in the Activity solely at my own risk. This includes all activities relating to on in connection with, and taking place, before, during or after, the Activity, including any activity, tour, travel, program or instruction in connection with the Activity, whether within or outside of Dominican Republic. I agree that I am voluntarily participating in the Activity and assume all risk of injury, death, illness, danger, crime, disease, damage, or loss to me (or my family, heirs or assigns) or to my personal property that might result. **I have consulted with a licensed physician, who verified I am in good physical condition to participate in the Activity.**

I agree on behalf of myself (and my personal representatives, heirs, executors, administrators, agents and assigns) to release and discharge Cross and CROSS CATHOLIC OUTREACH, INC., a Florida non profit corporation, and any affiliates, directors, officers, members, employees, agents, representatives, sponsors or any successors and assigns of any of the foregoing (each a "Releasee" and collectively, "Releasees") from any and all claims, causes of action (known or unknown), debt, controversy, damage or liability of any kind arising out of my participation in the Activity or any negligence or other fault on the part of any Releasees. **This release of liability includes, without limitation, loss or damage to property, illness, contracting diseases, injuries or death which are alleged to have resulted from any negligence or other fault on the part of Releasees or which may occur as a result of or in connection with (a) my participation in the Activity; or (b) any alleged improper or negligent supervision or guidance or participation in any respect in connection with the Activity by any Releasee or by any other individual not associated with a Releasee. I am waiving any right that I may have to bring a legal action to assert a claim against any Releasee's negligence or other fault.** This Waiver and Release shall include, but is not limited to, any claims for lost wages, benefits, commissions and remuneration of any kind, compensatory damages, punitive damages, attorneys' fees, equitable relief, or any other form of relief either in law or in equity, including, without limitation, any and all claims under Florida law, or under any other state, federal, or local law, statute, public policy, order, ordinance, or regulation, and all common law claims. I agree to indemnify each Releasee for all reasonable attorneys' fees and costs incurred in enforcing this Waiver and Release in the event that I (or anyone acting on my behalf) sue one or more of the Releasees.

Further, I hereby grant full permission and exclusive license to Cross to use any photographs, motion pictures, recordings, or any other record taken by or on behalf of Cross of me or my participation in the Activity, or any portion thereof, for any legitimate purpose including commercial advertising, and I agree that Cross shall be the sole owner of any such photographs, motion pictures, recordings or other records.



Any claim or dispute arising from or related to this agreement shall be settled by mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation, a division of Peacemaker Ministries. Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this agreement and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.

I acknowledge and represent that I have read and fully understand this Waiver and Release. I acknowledge I have been advised to consult an attorney before signing this Waiver and Release. I understand that this Waiver and Release affects my legal rights, and I represent that I have not relied upon any oral statements or representations of anyone to induce me to sign it. I acknowledge that I am signing his Waiver and Release freely and voluntarily and intend by my signature the complete and unconditional waiver and release of all liability to the greatest extent allowed by law.
